Current Reno and Clark County Electrical Card Holders & New NV Electrical Qualifications Card Holders

CEUs issued by the following ESP-approved providers will be accepted for CEU renewal requirements. The topic of the classes must be Electrical Code and Electrical Safety topics based only on the most recent versions. Classes based on the 2017 NEC and 2018 version of NFPA 70E are no longer valid for CEU requirements.

CEU (Continuing Education Unit) Requirements: CURRENT (Effective 1/1/2022):

To renew your Nevada Electrical Qualifications Card, you must obtain, every three years, at least 1.8 CEUs (18 hours of instruction) for Electrical Journeyman, Residential, Sign or Low Voltage Technician, or 3.0 CEUs (30 hours of instruction) for Master, related to electrical code and electrical safety-related topics. These CEUs must consist of the following at a minimum:

1. An 8-hour class (0.8 CEUs) must be from a code-change class highlighting code changes to the current edition National Electrical Code for the renewal period from an ESP-approved CEU provider.
2. A 4-hour class (0.4 CEUs) must be on Electrical Safety based on NFPA 70E current edition from an ESP-approved CEU provider.
3. The balance of the CEUs can be from ESP-approved providers on electrical code and electrical safety-related topics.
4. Only CEUs issued by specific ESP-approved organizations on electrical code and electrical safety-related topics will be accepted.

JOURNEYMAN RENEWAL (SUMMARY) – Overall total of **18** hours CEU credit needed for renewal. This amount must include: 8 hours (minimum) of 2020 NEC Code Change/Review, 4 hours (minimum) of NFPA 70E 2021 and remainder of hours must consist of electrical code or electrical safety-based material from Provider on ESP Approved Provider List.

MASTER RENEWAL (SUMMARY) – Overall total of **30** hours CEU credit needed for renewal. This amount must include: 8 hours (minimum) of 2020 NEC Code Change/Review, 4 hours (minimum) of NFPA 70E 2021 and remainder of hours must consist of electrical code or electrical safety-based material from Provider on ESP Approved Provider List.

FREQUENTLY ASKED QUESTIONS

I heard from Union/City/Friend/Co-Worker that ID Cards have been or will be discontinued.

Not True, ID Cards (Masters or Journeyman) are still required by Clark County, City of Las Vegas and City of Reno Admin Codes for the supervision of work.

Can I convert my Experior or National Assessments card to a new qualifications card without taking a test?

The ability to convert Experior or National Assessments cards to the previous ICC card without testing terminated on January 1, 2010.

If you have previously taken the G16 Master, G17 Journeyman, G18 Residential or G21 Low Voltage tests through ICC/Pearson Vue, you can be issued an Electrical ID Card through ESP. You must have a copy of your Pass Letter issued by Pearson Vue.

Is it necessary to convert an old master or journeyman card to the new issued card?

Yes. As with many agencies that regulate the electrical industry throughout the United States, ESP implemented a continuing education requirement for electricians. Under the old process, the cards had no expiration date and data was not maintained for individual card holders. The newer cards contain a picture of the card holder, which was a procedure implemented to prevent fraud by those who had not proven their qualifications through obtaining their own card.

I have a Nevada Contractors License. Why do I need a Master or Journeyman card in Nevada?

The State of Nevada does not regulate supervision on the job site or the installation of an electrical system. The requirement for a qualified individual on the job site to supervise the work is required per Clark County, City of Las Vegas and City of Reno Administrative Codes. In some instances, the license holder lives in other states and never sees the work being installed. The Nevada card is not a contractor's license; it is a qualification card and is intended to provide a competent level of supervision at the job site.

Do I need to carry an Electrician ID Card?

Yes. At every job site there must be an electrical qualified individual.

When Does my Current ICC Card Expire?

- ICC – Website will give you the expiration date (<https://www.iccsafe.org/verify>)

Do I need to retake the electrical exam to get new card?

- Current ICC Card Holders can apply for the new card with required CEU's
- New expiration date will be three (3) years from issue date
- If card has been expired more than 1-year (366 Days), test must be retaken

Will my current electrical ID Card still be valid and recognized by ESP?

Yes, if it was issued within the last three years. ID cards are valid for a three-year period.

How do I apply for a new Nevada Electrical Qualification Card?

After passing the ICC National exam, apply to ESP at this web address: <http://electricalsafetypro.org/>

How do I renew my Electrician ID Card?

Obtain CEUs through approved CEU providers and then complete the renewal requirements. Go to ESP at this web address: <https://electricalsafetypro.org/> and download or submit the online ID Card Renewal Application. Submit the application, proof of required CEUs, supporting documents and the appropriate fees.

Where can I get the education and obtain CEUs needed?

What classes do not qualify for your CEU's?

- First-Aid and CPR
- Non-electrical classes
- Management classes
- Fire Alarm classes
- Lighting classes
- Classes from non-approved providers
- Outdated code updates (2014 & 2017 NEC)
- OSHA 10 or OSHA 30 classes

If my ID card is expired, can I renew it?

Yes, an ID card can be renewed within one year of the date of expiration. Obtain the CEUs required for the renewal and submit the application. The regular renewal fee is required in addition to a reinstatement fee. If your ID Card has been expired for more than one year, you must once again take the exam and have a passing score to obtain a new card.

I'm having issues determining who to contact... Who issues the ID cards?

- ICC - Application to take the Test
- ICC - Administers the online test (PRONTO)
- Pearson Vue - Administers the In-Person Test
- ESP - ID Card issuing & renewal organization

Does permission need to be given by AHJ to apply for testing?

- No permission needs to be granted by AHJ
- No work hours documentation is required by ESP at this time
- Documentation of hours may be required for apprenticeship programs

Does ESP give the test?

- Exam ID # G16 - ICC National Master Electrician Exam
- Exam ID # G17 - ICC National Journeyman Electrician Exam
- Exam ID # G18 - ICC National Residential Electrician Exam
- Exam ID # G21 - ICC National Low Voltage Electrician

The master/journeyman electrician exams are classified under Contractor/Trade exams (Type), National/All (State)

Testing is available in-person or online. The current testing administered by ICC/Pearson Vue is based on the 2017 NEC. The NEW 2020 NEC testing will be available (online only) late first quarter 2022.

As of July 2020, the G16 Master Electrician Exam and the G17 Journeyman Electrician exams are available online through ICC's PRONTO testing. The G18 Residential Electrician Exam is not offered online but must be taken in person through ICC/Pearson Vue.

PLEASE NOTE: The F series electrician exams offered through the PRONTO online exam system are based on the 2014 National Electrical Code and will not be accepted for purposes of issuing a Nevada Master or Journeyman card. Only the G series exams will be accepted.
